### Entry Fees:

As specified in Section 2.1 of the Championship/Series Regulations, an entry not accompanied by the correct Entry Fee is not a valid entry. Drivers are reminded that once they have notified the Club of their intention to enter a meeting, by way of a booking, they have agreed to take part in the meeting and agree to comply with the Entry Fee payment terms, which shall be 14 days prior to the start date of every meeting/round. Late Entry/Payment Fee surcharges shall be payable for any entries received after midnight on the Sunday, two working weeks prior to the start date of the meeting. **The Late Entry/Payment Fee is £25.00** as specified in the Supplementary Regulations. Refunds will only be payable per the Refund Policy stated below.

In consideration of acceptance of this entry I agree that neither any one of or any combination of the MSA and its associated clubs, the organisers, the track owners or other occupiers, the promoters and their respective officers, servants, representatives, and agents (the "Parties") shall have any liability for loss or damage that be sustained or incurred by me as a result of participation in the Event including but not limited to damage to property, economic loss, consequential loss howsoever caused. Nothing in this clause is intended to or shall be deemed to exclude or limit liability for death or personal injury. 4. To the fullest extent permitted by law I agree to indemnify and hold harmless each of the Parties in respect of any loss or damage whatsoever and howsoever arising from my participation in this event. 5. To the best of my belief the driver(s) possess(es) the standard of competence necessary for an event of the type to which this entry relates and that the vehicle entered is suitable and roadworthy for the event having regard to the course and the speeds which will be reached. 6. Any application form for a Licence which was signed by a person under the age of 18 years was countersigned by that person's parent/legal guardian/guarantor, whose full names and addresses have been given. 7. If I am the Parent/Guardian/Guarantor of the driver I understand that I shall have the right to be present during any procedure being carried out under the Supplementary Regulations issued for this event and the General Regulations of the MSA. As the Parent/Guardian/Guarantor I confirm that I have acquainted myself and the minor with the MSA General Regulations, agree to pay any appropriate charges and fees pursuant to those Regulations (to include any appendices thereto) and hereby agree to be bound by those Regulations and submit myself without reserve to the consequences resulting from those Regulations (and any subsequent alteration thereof).
